Main Applications

Riblene FL 30 I is recommended for general blown film applications, for the production of shrink film for low loads, also with low thickness, for lamination film and for blend. Due to its peculiarities Riblene FL 30 I is recommended for the production of high purity films.

Processing notes

Riblene FL 30 I is easily processable using blown film technology. Melt temperature should be between 160 °C and 190 °C. Recommended thickness: 25 - 80 µm.

Storage and Handling

Riblene FL 30 I is supplied in pellet form. This material may readily be conveyed and bulk fed through equipment designed for conventional pelletised polyethylene resin, provided the equipment is designed to prevent accumulation of the fines and dust particles that are contained in all polyethylene resins. These fines and dust particles can, under certain conditions, pose an explosion hazard. We recommend that the conveying system used be equipped with filters of adequate size, operated and maintained in such a manner to ensure that no leaks develop and earthed adequately. We further recommend that good housekeeping should be practised throughout your facility.

The product should be stored in dry conditions at temperatures below 50 °C and protected from sunlight. Improper storage can initiate degradation which results in odour generation, colour changes and can have negative effects on the physical properties of the product.
