The 'bio attributed' product Clearflex CL D0 BA is a highly sustainable VLDPE produced using bionafta from renewable raw materials together with traditional raw materials. In order to attribute the sustainable feedstock component to the final product, Versalis applies the Mass Balance approach, a recognized methodology that allows to trace the flow of materials along the value chain and to assign the sustainability characteristic of the raw material to the final product on a documentary basis.

Clearflex CL DO BA provides the same chemical composition and physical-mechanical performance of the traditional grade, in addition is accompanied by a sustainability declaration that certifies the share of bio attributed product. It is a linear low-density polyethylene with antioxidants characterised by a very low density and suitable for cast film technology. The production of Clearflex CL DO BA allows to contribute to the circular economy, since the bionafta used derives from renewable sources (e.g. vegetable oils). Clearflex CL DO BA will be bio attributed for 75%. The exact amount of "bio attributed" product will be reported in the sustainability certificate issued upon the delivery of the product.

MAIN APPLICATIONS

Clearflex CL DO BA is recommended as cling agent in stretch film but it is also used for applications in which soft touch and flexibility are required, for the improvement of impact resistance when used as additive with other poluplefins formulated with or without mineral fillers.

PROCESSING NOTES

Clearflex CL D0 BA is easily processable using cast film technology. Melt temperature should be between 220°C and 270°C.

STORAGE AND HANDLING

Clearflex CL DO BA is supplied in pellet form. This material may readily be conveyed and bulk fed through equipment designed for conventional pelletized polyethylene resin, provided the equipment is designed to prevent accumulation of the fines and dust particles that are contained in all polyethylene resins. These fines and dust particles can, under certain conditions, pose an explosion hazard. We recommend that the conveying system used be equipped with filters of adequate size, operated and maintained in such a manner to ensure that no leaks develop and earthed adequately. We further recommend that good housekeeping should be practiced throughout your facility. The product should be stored in dry conditions at temperatures below 50°C and protected from sunlight. Improper storage can initiate degradation which results in odor generation, color changes and can have negative effects on the physical properties of the product. Before using this product, it is recommended to read and understand the relevant Safety Data Sheet.
